IIG is seeking Expressions of Interest (EOI) for the Operation and Maintenance (O&M) of the Swan Hill Solar Farm (VIC). IIG is targeting an initial 5-year O&M term with the option for a further 5 years.

The Swan Hill Solar Farm Project (SHSF) is located approximately 2 km west of the township of Swan Hill on Blackwire Reserve. SHSF is a 19.282 MWp DC/ 14.4 MWAC solar farm consisting of a Nextracker single axis tracker system with SMA Sunny Central 2500MVA inverters. The PCUs are used to step up voltages to 22kV. SHSF contains 2 separate HV Feeder circuits, which in turn, each supply 7.5 MWp to Powercor's SHL1 and SHL2 distribution feeders.

The plant reached Practical completion in mid-July 2018.

The O&M services broadly required (but not limited to) are:

- Daily management and operation of the solar facilities:
 - Fault notification and response
 - Grid interactions / Switching
 - Spare part management
 - Warranty management

- Security
- Reporting
- Preventative and corrective maintenance of
 - Modules/tracking/piles system
 - Combiner boxes
 - PCU's Inverters/transformers
 - 22kV switchroom
 - SCADA system
 - Weather stations and pyranometers
 - Security system
 - Balance of plant including vegetation management and civil works
- Remote Monitoring and Control of facility
- Minor capital works if required
- Compliance with applicable laws, regulatory approvals, permits and related agreements

The EOI proposal should address the following criteria:

- Inclusions and structure of proposed O&M service offering including key contractual terms such as:
 - Limitation of liability cap
 - Availability guarantee liquidated damages cap
 - Security options; Parent Company Guarantee/performance bond
- Approach to positive social and environmental impacts including procurement policies
